Introduction

Turin, Lund, El Escorial, Warwick, Maastricht, Warsaw, Lyon, Chania, Aarhus, Blankenberge, Regensburg, Milan, Jyväskylä, Paris, Seville, Lisbon, San Francisco, Prague, Oslo, Amsterdam, Tallinn, London, Paphos, Bonn, Turin. The circle is round, as round can be. It has no end but perhaps more importantly following a circle you always end up where you started. EALE had its founding conference in 1989 in Turin. After 25 years EALE is back where it once started – in Turin.

A lot has changed since the first meeting. At the founding conference EALE was bilingual. Papers and presentations could be in English or French and in some of the sessions there were interpreters from English to French and vice versa for those who needed it. This was all the more remarkable as of the 185 participants only 26 came from France and 13 from the UK.

The idea of a bilingual EALE was abandoned in 1991. The main reason was that only a few people wanted to present in French and those who did often spoke so quick that the interpreters frequently lost track and in fact so did the non-French speaking audience.

At the first conferences hard copies of papers were provided. The idea that all participants should have hard copies of all papers presented was very persistent. Up to 1996 each participant was welcomed with a huge pile of hard copies. Later on, all conference papers were put on a CD and currently all conference papers are available through the Web.

Over the last 25 years, keynote speakers, including Nobel prize winners gave inspiring lectures. For this year's anniversary conference in addition to the three keynote speakers we have invited distinguished labour economists who will survey nine domains of labour economics commemorating the scientific progress that has made over the past 25 years.

Looking back, I believe that in 25 years the EALE conference has become an important yearly event for experts in Labour Economics in Europe and elsewhere. With new challenges ahead, I am convinced that research in labour economics will contribute to the policy debate on how to tackle the current labour market problems related to the Great Recession.

I wish you all a very interesting and enjoyable conference!

About Your EALE Host

The **Department of Economics and Statistics of the University of Torino** is the heir of one of the Italian most ancient and most prestigious institutions for the study of economics: the *Laboratorio di Economia Politica*, funded at the beginning of the academic year 1893 – 94. It was promoted by Salvatore Cognetti de Martiis (1844 – 1901), Professor of Economics at the University of Torino since 1878. The *Laboratorio di Economia Politica* was established as a separate branch of the Economics section of the Institute for Law and Politics of the School of Law. Afterwards it became part of the Royal Industrial Museum of Torino, which was then merged with the School of Application for Engineers to create the Polytechnic of Torino in 1906. Thanks to public and private funds, the *Laboratorio* created a library that has constantly been growing over time. Since 1906 the *Laboratorio* was named, after his founder, *Laboratorio di economia politica “S. Cognetti de Martiis”*. The new chair of Economics and director of the *Laboratorio* was Achille Loria (1857 – 1943), one of the most famous Italian economists between the two centuries. He was in charge for almost thirty years, from 1903 to 1932; since 1908 he was assisted by Luigi Einaudi (1874 – 1961), who was deputy-director. This position appertained to the chair of Economics and Industrial Law of the Polytechnic (held by Einaudi up to 1935). Under their direction the *Laboratorio* was partially transformed: in 1926 it was separated from the Polytechnic, while in 1935 the School of Economics of the University of Torino was established. The *Laboratorio* became a seminar (and then an institute) of the School of Law. At the beginning of the 20th century Einaudi became the leader of what may be called the Turin school of economics.

In 1988 the *Laboratorio* formally turned into the “*Dipartimento di Economia S. Cognetti de Martiis*” that was the birthplace of several research centers, such as: LABOR (labor economics), CHILD (economics of work and family), LEI & BRICK (business innovation), Ebla (economics of cultural heritage), CESMEP (history and methods of economics), CIRPET (emerging economies and developing countries), IRIS (sustainability and environment, created in collaboration with the Department of Human Biology). Other important areas of research are public economics, development economics and cooperation, comparative economic studies, industrial economics and multinational corporations, behavioral economics and complexity. The Department has also helped to establish postgraduate programs in Piedmont: CORIPE Piemonte with its specialized Masters, together with other economic departments of the University of Torino and Piemonte Orientale; the PhD program in economics of Piedmont Universities, in collaboration with the Collegio Carlo Alberto and UNESCO.

About Luigi Einaudi

Luigi Einaudi (1874–1961) is one of the most representative figures in Italian post- unification history. Ranking among the major Italian economists, together with other great scholars such as Maffeo Pantaleoni and Vilfredo Pareto, his field of activity was, however, not limited to economics. For almost 60 years, from the end of the 1880s to the 1950s, he was a leading figure in Italian cultural and political life. Professor at the University of Torino and at the Bocconi University of Milan, the director of prestigious journals such as *La Riforma Sociale* and *Rivista di Storia Economica*, a columnist writing on economic issues first for *La Stampa* and subsequently for *Il Corriere della Sera*, the Italian correspondent of *The Economist*, Senator of the Kingdom and, in the later post-war period, the architect of economic stabilization as Governor of the Bank of Italy, Budget Minister and Vice-President of the Council of Ministers in the De Gasperi government, he was then elected the first President of the Italian Republic after the Constitution came into force. Economic historiography places Einaudi in the silver age of Italian marginalism, the era that followed the golden age of Pareto and Pantaleoni.

City of Torino

Torino is packed with palaces and piazzas, great museums, fashionable boutiques, and glittering cafés and restaurants, enough to make this brand baroque jewel in the foothills of the Alps a top tourist destination. Torino became the home of the powerful Savoy family in the 16th century. The House of Savoy spent lavishly on its showpiece, just when baroque was the height of fashion. Luxuriously ornamented buildings and churches abound.

Crowned by the majestic Alps, the town is remarkable for the harmony of its various architectural styles and the excellence of its museums! From Baroque to Art Nouveau and Modernism, Torino has an original "ensemble".

Torino also has an enviable food and wine tradition. A gastronomic environment, renowned for its delicacies, prestigious wines, the sweet glory of its chocolate and aperitifs, not only the famous Vermouth and Martini, but also the pleasant ritual that keeps fascinating its visitors.

A trip to Torino is also synonymous with entertainment, music, shopping, emotions, mystery and curiosity which, together with a superb range of accommodations and restaurants and the

current renaissance of art and urban architecture, makes Torino one of the most exciting and modern European towns.

Of special interest to economists is that Giuseppe Lodovico Lagrangia (1736-1813) was born in Torino. He was a self-taught mathematician. His first work was sent in a letter to Giulio Fagnano in 1754 under the name of Luigi De la Grange Tornier. Later he made numerous important contributions in mathematics and mechanics. In 1766 he moved to Berlin and later to Paris (1787) where he died in 1813. The house where he was born and grew up can be seen in Torino on via Lagrange.

Another even more important person for economists is Vilfredo Pareto (1848-1923). He was born in Paris but the family moved to Piedmont circa 1858. In Torino Pareto studied classics and engineering at the Polytechnic Institute of Torino. After finishing his study in 1870 he became director of the Rome Railway Company and later, in 1874, he became the managing director of an iron and steel company in Firenze. In 1889, after the death of his parents, Pareto changed his lifestyle and moved to Fiesole. He began writing numerous polemical articles against the Italian conservative government and gave public lecture at a working man's institute. Through his contact with Maffeo Pantaleoni (1857-1924) he was introduced to economic theory, in particular to the Walrasian strand. In 1894 he got a position in Lausanne and there, he gave his famous lectures in economics.

What should we economists have done without a Lagrange function and Pareto optimum?

Andrea Ichino is currently a professor of economics at the University of Bologna. He graduated from Bocconi University in 1985 with a thesis on the effects of wage subsidies on unemployment. He completed his Ph.D. program at MIT in Cambridge, Massachusetts, in 1990 with a thesis on flexible compensation as a risk-sharing device. From 1990 to 1997, he taught and researched at IGER, Bocconi University. From 1997 until 2007 he was a professor of economics at the European University Institute in Florence, Italy. He has been Editor in Chief of Labour Economics, member of the scientific committee of the European Association of Labour Economists and he is a fellow of CEPR, IZA and CESifo. His research interests include group interactions and network effects, the economics of education, intergenerational social mobility and income inequality, rigidity and flexibility in European labor markets, labor law and economics, as well as family structure and unemployment in southern Europe.

How to Get Published

Good research deserves to be published, to be widely read, and to be recognized by fellow researchers and the community. The current research (and funding) climate makes it necessary that you are successful in being published: "Publish or Perish". This then raises the question, how can you achieve that goal?

Success essentially depends on three components:

1. The ability to determine the best possible publication strategy for your research findings.
2. The best possible way to write your article.
3. The most effective interaction with editors.

Key to success in this context is your ability to put yourself in the position of readers, reviewers and editors.

Important considerations in journal selection are a realistic assessment of the quality of the research and of the audience you intend to reach.

Manuscript writing means not just applying one golden tip. It is essentially telling your story to your readers in an engaging way; and avoiding common mistakes and deficiencies including poor language. Avoidable mistakes can lead to unnecessary rejection of your manuscript.

Finally, it is your open, non-defensive attitude towards the editors and the reviewer comments, that will not only increase the likelihood of getting your manuscript accepted for publication, it is also likely that your published paper has improved thanks to their comments.

By consistently applying these principles, and by understanding the publishing process and the editors' and reviewers' expectations, you are likely to become a more successful author.

Joshua Angrist (MIT, USA)

Joshua Angrist is the Ford Professor of Economics at MIT and a Research Associate in the NBER's programs on Children, Education, and Labor Studies. A dual U.S. and Israeli citizen, he taught at the Hebrew University of Jerusalem before coming to MIT. Angrist received his B.A. from Oberlin College in 1982 and also spent time as an undergraduate studying at the London School of Economics and as a Masters student at Hebrew University. He completed his Ph.D. in Economics at Princeton in 1989. His first academic job was as an Assistant Professor at Harvard from 1989-91. Angrist's research interests include the effects of school inputs and school organization on student achievement; the impact of education and social programs on the labor market; the effects of immigration, labor market regulation and institutions; and econometric methods for program and policy evaluation. Angrist is a Fellow of the American Academy of Arts and Sciences, The Econometric Society, and has served on many editorial boards and as a Co-editor of the Journal of Labor Economics. He received an honorary doctorate from the University of St Gallen (Switzerland) in 2007 and is the author (with Steve Pischke) of *Mostly Harmless Economics: An Empiricist's Companion* (Princeton University Press, 2009). In addition to academic work and teaching at MIT, Angrist occasionally ventures abroad to teach an Empirical Strategies short course based on *Mostly Harmless Econometrics*.

Have research lines faded away due to lack of interest or were they emptied by accumulated contradictory evidence? Have advances in labour economics improved the working of real life labour markets in European countries, provided reliable guidance for policy decision or at least markedly improved our understanding of the functioning of labour markets? Has the market value of a labour economist increased? The papers will be published in a Special Issue of Labour Economics, celebrating its 20th anniversary.
